ORDER:

In the letter 7th read above, Member Convenor, High Power Committee, after obtaining the inspection report from the District Level Team, Vijayawada has recommended for issuance of an Essentiality Certificate to 'Missionaries of Compassion, D.No.19-61, Jose Nagar, Vangayagudem, Eluru, West Godavari District' for establishment of Good Samaritan College of Nursing, D.No.19-61, Jose Nagar, Vangayagudem, Eluru, West Godavari District to start B.Sc., (Nursing) Course with an intake of 60 (Sixty) seats per annum. As per the report, the college is having clinical affiliation with 1) Good Samaritan Cancer & General Hospital, Vangayagudem, Eluru [Parent Hospital/300 beds], 2) Murali Krishna Multi Speciality Hospital, Eluru [50 beds] and 3) Vijaya Hospitals, Eluru [50 beds], for which, NOC has been issued by the Director of Medical Education vide Procs.No. 2372488/NE/2024, Dt.13.03.2024.

2. Government after examination of the matter, hereby issue an Essentiality Certificate to Missionaries of Compassion, D.No.19-61, Jose Nagar, Vangayagudem, Eluru, West Godavari District for establishment of Good Samaritan College of Nursing, D.No.19-61, Jose Nagar, Vangayagudem, Eluru, West Godavari District to start B.Sc., Nursing Course with an intake of 60 (Sixty) seats per annum, subject to obtaining affiliation from Dr.N.T.R. University of Health Sciences, Vijayawada and approval of the Indian Nursing Council, New Delhi and also subject to the conditions to comply with the rules and regulations of INC Act 8 of 1947 (guidelines, minimum requirements of establishment of college of Nursing)/ APNMC, Dr. N.T.R. University of Health Sciences statutes and G.Os issued by the Government from time to time.

3. The Essentiality Certificate issued in Para-(2) above is subject to the following conditions:

- i. That the Institute should obtain affiliation duly fulfilling all the conditions stipulated as per the statutes of Dr. N.T.R. University of Health Sciences, Vijayawada and payment of annual affiliation fee as prescribed from time to time by Dr. NTRUHS and clearance from the Indian Nursing Council, New Delhi. In case of the aforesaid Educational Society fails to fulfil the conditions or fails to start the B.Sc., Nursing course within a period of one year, the permission now accorded will be cancelled.
- ii. The annual intake of students should not exceed as specified above to the institute and the institute should fulfil and abide by the rules and regulations notified by Government in G.Os 1st and 2nd read above and subsequent amendments issued thereon from time to time.

4. The aforesaid Educational Society should also obey the following instructions scrupulously:

- i. The Institute should run regularly with the required infrastructure facilities, equipment, teaching staff, office rooms and clinical facilities, hostel facility, library books as per the statutes and regulations of Dr. NTRUHS and Indian Nursing Council and should run in the best interest of students and it will be inspected by an inspecting officer appointed by Government, Dr. NTRUHS or Indian Nursing Council, New Delhi.
- ii. The students hostel, wherever provided is adequately furnished with appropriate areas for their comfortable stay and provision is made for their indoor/ outdoor games.
- iii. The procedure prescribed by Government or Dr. NTRUHS for the selection, collection of fee, admission or students, rule of reservation, local, non-local areas and conducting examinations should be scrupulously followed.
- iv. The Institute should not have or open branches on the same place or elsewhere in the State or outside the State.
- v. The Institute should obtain the permission of the Indian Nursing Council, New Delhi to start the Nursing College. In case, the applicant fails to create infrastructure for the Nursing Colleges as per INC norms, the fresh admissions will be stopped by the State Government.
- vi. The society shall submit an affidavit certifying that there are no other educational institutions located in the same premises.

5. The Essentiality Certificate issued in Para-(2) above, is also liable for cancellation whenever the Government or Dr. N.T.R. University of Health Sciences or Indian Nursing Council forms the opinion based on an inspection report that the aforementioned 'Missionaries of Compassion, D.No.19-61, Jose Nagar,Vangayagudem, Eluru,West Godavari District' is not running the

college in the best interest of the students or commits any irregularity or violates any rule /regulation after giving (15) days notice to the Educational Society to show cause against the proposed cancellation and pass appropriate orders after considering the explanation, if any, offered by the Society against the Show cause notice.
